OFFICIAL WAIVER & RELEASE OF LIABILITY

Event: Brews & Bags Cornhole League

Organizer: Brewscape Beer Co, hereafter referred to as "The Brewery."

Timeline: May 2026 - August 2026

PLEASE READ CAREFULLY BEFORE SIGNING.

1. ASSUMPTION OF RISK I acknowledge that participating in the "Brews and Bags" cornhole league carries inherent risks, including but not limited to: being struck by flying cornhole bags or boards, tripping over equipment, collisions with other participants or spectators, and physical exertion. I voluntarily assume all risks associated with participation in this activity.

2. RELEASE OF LIABILITY In consideration of being allowed to participate, I hereby release, waive, and discharge "**The Brewery**," its owners, employees, volunteers, and agents from any and all liability, claims, demands, or causes of action arising out of my participation, including claims resulting from the negligence of "The Brewery." This includes any injury, illness, or property damage that may occur during the league play, warm-ups, or associated gatherings.

3. ALCOHOL CONSUMPTION I acknowledge that "Brews and Bags" takes place in a brewery environment where alcohol is served. I agree to drink responsibly and strictly adhere to all local and state laws regarding alcohol consumption. I understand that "The Brewery" reserves the right to refuse service to anyone who appears intoxicated and may disqualify any participant whose impairment poses a safety risk to themselves or others.

4. PERSONAL PROPERTY I acknowledge and agree that I am solely responsible for my personal belongings, including but not limited to custom cornhole bags, electronics, and vehicles. "The Brewery" is not responsible for the loss, theft, or damage of any personal property at any time during the event.

5. EQUIPMENT & CONDUCT I agree to use all equipment (boards, bags, and scorecards) properly and to follow the official league rules. I agree to conduct myself in a sportsmanlike manner. "The Brewery" reserves the right to remove any participant from the league for unsafe behavior or harassment of other players or staff.

6. DOG & MINOR POLICY If I bring a dog or a minor to the event area, I certify that I am solely responsible for their supervision and behavior. I assume full legal and financial responsibility for any actions of my dog or guests, including bites, property damage, or injury to other participants. All dogs must remain on a leash at all times.

7. MEDIA RELEASE I grant "The Brewery" permission to use photographs, video, or audio recordings of me taken during "Brews and Bags" events for marketing, website, and social media purposes without compensation.

8. MEDICAL CONSENT In the event of an emergency, I consent to receive medical treatment deemed necessary by emergency personnel, and I agree to be responsible for all related costs.

9. HEALTH & PHYSICAL CONDITION I certify that I am physically fit and have no medical condition that would prevent my safe participation in this league. I acknowledge that I am responsible for my own physical well-being during play.

10. INDEMNIFICATION I agree to indemnify and hold harmless "The Brewery" from any and all claims, actions, suits, costs, expenses, damages, and liabilities, including attorney's fees, brought as a result of my involvement in the "Brews and Bags" league.

11. SEVERABILITY I further expressly agree that the foregoing waiver and release of liability is intended to be as broad and inclusive as is permitted by law. If any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect.
